

I'll update</p> <p>12 you on the current budget</p> <p>13 situation first, and then</p> <p>14 quickly bring you up to date</p> <p>15 on several ongoing matters.</p> <p>16 One issue dominates</p> <p>17 all of State government and</p> <p>18 certainly is the focus of our</p> <p>19 team at ADEM, and that is</p> <p>20 maintaining adequate funding</p> <p>21 to accomplish our mission for</p> <p>22 the balance of the current</p> <p>23 fiscal year and securing</p>	Page 7	<p>1 As you know, The</p> <p>2 Department's operating budget</p> <p>3 is funded primarily from three</p> <p>4 sources: Federal funds in the</p> <p>5 form of grants to administer</p> <p>6 Federal statutes; Departmental</p> <p>7 fees from the regulated</p> <p>8 community; and State General</p> <p>9 Funds.</p> <p>10 For Fiscal Year</p> <p>11 2012, we know for certain that</p> <p>12 two of these primary funding</p> <p>13 sources, the General Fund</p> <p>14 allotment and Departmental</p> <p>15 fees, will change</p> <p>16 significantly from the just</p> <p>17 completed fiscal year 2011.</p> <p>18 Our current 2012</p> <p>19 General Fund allotment is</p> <p>20 \$4.2 million, which is</p> <p>21 \$2 million less than our</p> <p>22 original FY 2011 General Fund</p> <p>23 allotment. Such a massive cut</p>
Page 6	<p>1 adequate funding for the</p> <p>2 upcoming fiscal year. Failure</p> <p>3 to accomplish our mission</p> <p>4 would mean EPA taking over our</p> <p>5 programs and having Alabama's</p> <p>6 environmental and economic</p> <p>7 future determined by the</p> <p>8 federal government. In these</p> <p>9 dire financial times, our</p> <p>10 budget will continue to be a</p> <p>11 limiting factor on what this</p> <p>12 Department can achieve. It</p> <p>13 remains incumbent upon us to</p> <p>14 determine which of our</p> <p>15 priorities are mission</p> <p>16 critical and maintain them at</p> <p>17 all costs.</p> <p>18 Allow me to recap</p> <p>19 The Department's financial</p> <p>20 position for fiscal year 2012</p> <p>21 and then forecast our</p> <p>22 financial prospects for fiscal</p> <p>23 year 2013.</p>	Page 8	<p>1 would normally be catastrophic</p> <p>2 especially following on the</p> <p>3 heels of a 30-percent cut the</p> <p>4 previous year, but as you are</p> <p>5 aware, the Commission passed a</p> <p>6 19-percent fee increase at its</p> <p>7 October meeting that will go</p> <p>8 into effect later this month.</p> <p>9 This increase is expected to</p> <p>10 offset a large part of this</p> <p>11 year's General Fund reduction</p> <p>12 and stave off the worst</p> <p>13 effects of the reduction.</p> <p>14 There do, however,</p> <p>15 remain two wild cards in FY</p> <p>16 2012; one with our Federal</p> <p>17 funding and one with our</p> <p>18 General Fund allotment.</p> <p>19 Although all current</p> <p>20 indications are that Federal</p> <p>21 funding for our continuing</p> <p>22 programs will remain stable,</p> <p>23 this is not certain, because</p>

1 no Federal budgets for FY 2012
2 have passed. As you may
3 remember, the Federal
4 Government never did pass a
5 budget for FY 2011.
6 As for our FY 2012
7 State General Fund allotment,
8 we may well suffer additional
9 cuts on top of the \$2 million
10 we've already lost. Although
11 we will probably not know for
12 certain until spring, there
13 are initial indications that
14 some level of proration in the
15 General Fund is probable for
16 the FY 2012. Until we do know
17 for certain whether these
18 proration cuts will
19 materialize and to what
20 degree, I cannot report what
21 additional actions The
22 Department will take to absorb
23 them. At this time, we

1 believe the worst of the
2 potential impact will be
3 mitigated by the previously
4 approved fee increase.
5 As challenging as
6 the FY 2012 budget is, it
7 appears the FY 2013 budget
8 will be worse. Our
9 preliminary meetings with the
10 State Finance Department have
11 given us the opportunity to
12 present our list of "wants and
13 needs" to the Finance Director
14 and to make our case for at
15 least level funding, if not
16 increased funding, for FY
17 2013. Although the numbers
18 are not yet final, it is clear
19 that there will be a
20 significant deficit in the
21 overall General Fund for FY
22 2013. It is also clear that
23 we, along with every other

1 General Fund agency, will be
2 funded at a much lower level
3 than FY 2012.
4 To the casual
5 observer looking at The
6 Department's funding scheme,
7 this might not seem like a
8 major difficulty, because
9 percentage-wise The Department
10 receives a rather small
11 portion of its total funding
12 from the General Fund.
13 However, although our State
14 General Fund allotment is
15 small in comparison to our
16 Federal funding and income
17 from permit fees, it is
18 critical, because the General
19 Fund allotment provides the
20 required match funds for our
21 Federal funds. We are now at
22 the point where net decrease
23 in our General Fund allotment

1 will result in the loss of
2 Federal funds. Approximately
3 40 percent of our total budget
4 is from the Federal
5 Government. So a significant
6 percentage reduction due to
7 lack of matching funds -- lack
8 of State matching funds would
9 have a dramatic impact on The
10 Department.
11 There are two
12 primary questions going
13 forward: How much will the FY
14 2013 General Fund allocation
15 be cut? And how do we absorb
16 the cut without compromising
17 our critical functions? We
18 will continue to engage with
19 the Finance Department over
20 the next several weeks and
21 should know for certain what
22 the Executive Branch's
23 recommended allotment for ADEM

1 will be by the first of the
2 year. The Governor will then
3 transmit his proposed budget
4 to the Legislature for its
5 consideration during February.
6 We will not know our final
7 General Fund allotment until
8 the General Fund budget is
9 passed by the legislature in
10 April or May. In the
11 meantime, we will continue to
12 evaluate every part of The
13 Department for new
14 efficiencies to be implemented
15 and for noncritical functions
16 that could be eliminated.
17 The adoption of the
18 19-percent permit fee
19 increase, along with the
20 continued streamlining of
21 operations, are key components
22 of our efforts to overcome the
23 financial challenges in both

1 FY 2012 and 2013 without
2 compromising our mission to
3 assure the citizens of the
4 State a safe, healthful, and
5 productive environment.
6 We must and we will
7 be prepared to meet the
8 challenges of these new cuts
9 well before they become final,
10 and we will continue to
11 deliver the best service
12 possible within the confines
13 of our new economic reality.
14 As you're aware, one
15 of the ways The Department is
16 addressing the budget
17 challenges is through the use
18 of technology. I've discussed
19 on numerous occasions ongoing
20 projects such as e-DMR, e-NOI,
21 e-file, and now e-complaint,
22 and the electronic flow of
23 State databases to the EPA

1 data systems. These projects
2 have multiple benefits.
3 Clearly, they help us keep our
4 costs down. They also improve
5 the accuracy of our systems.
6 The e-file system also allows
7 all citizens to review
8 Departmental records,
9 including permits,
10 inspections, and enforcement
11 actions.
12 Additionally, our
13 Web site allows citizens to
14 submit complaints electrically
15 and to track The Department's
16 activities regarding that
17 complaint.
18 That is the latest
19 snapshot of our budget
20 situation and what we are
21 doing to deal with it.
22 Moving now to
23 nonbudget matters, I am

1 pleased to report to you that
2 after some extended
3 discussions with EPA and the
4 efforts of many people and
5 organizations over the last
6 thirty years, the EPA has
7 requested public comment on a
8 proposed action to declare
9 Jefferson and Shelby Counties
10 an attainment area for
11 short-term and long-term fine
12 particle standards. This is
13 quite an accomplishment,
14 because since being classified
15 as a nonattainment area more
16 than thirty years ago, fine
17 particulate pollution has been
18 steadily declining, but the
19 standard for attainment has
20 been declining faster. And
21 the area has, in effect, been
22 chasing, but never catching up
23 to, the standard. Well, those

Page 17	<p>1 in the area can be proud that 2 they have now caught the 3 standard. I extend The 4 Department's congratulations 5 to all involved. 6 On another matter, 7 as you and many in this room 8 are well aware, the 9 legislature in its last 10 session adopted legislation 11 implementing a two-year 12 moratorium on the permitting 13 of new or expanded municipal 14 solid waste landfills of a 15 certain size. During the 16 two-year moratorium, the 17 legislation charges The 18 Department, along with the 19 Alabama Department of Public 20 Health, to review the State's 21 Solid Waste Plan to determine 22 if changes are appropriate. 23 Our plan to do this involves</p>	Page 19	<p>1 the final stage before efforts 2 transition to the recovery 3 phase. When the transition 4 from response to recovery 5 occurs, the Federal On-Scene 6 Coordinator, in this case, the 7 U.S. Coast Guard, will no 8 longer be in place, and the 9 State will deal with BP 10 directly. In anticipation of 11 the changeover, the Stage V 12 plan provides a road map to 13 complete all response 14 activities, including those 15 that will carry over into the 16 recovery phase. The cleanup 17 standard in all cases will be 18 no visible oil, which is an 19 exceptionally high standard 20 and is critical to both the 21 environment and the tourism 22 industry on our Gulf beaches. 23 Finally, I'd like to</p>

9 the U.S. EPA replaced a cap
10 and trade program in the
11 thirty-one states east of
12 Mississippi with a brand-new
13 program. That former program
14 was known as the Clean Air
15 Interstate Rule, and it had
16 been voided by a court some
17 years before. We, meaning
18 ADEM, had been administering
19 that program at the State
20 level from regulations y'all
21 adopted five or six years ago.
22 And so now that EPA had
23 replaced that program, our

1 care rules on the books are
2 null and void. They cannot be
3 met by the sources that are
4 subject to them.
5 The new rule that
6 EPA has adopted will be
7 administrated by the EPA
8 during calendar year 2012.
9 And we hope to come back
10 before y'all in calendar year
11 2012 asking you to adopt rules
12 that will transfer privacy
13 from the Feds to ADEM
14 beginning January 1st, 2013.
15 So, again, the point there is
16 that for the calendar year
17 2012, EPA will run a new
18 program.
19 So we held a public
20 comment period beginning
21 September the 26th, ending
22 November the 10th. Held a
23 public hearing on November the

12 consideration proposed
13 revisions to Chapter 15 of
14 Division 6 of the
15 Administrative Code of The
16 Department of Environmental
17 Management. These proposed
18 regulations are necessary to
19 implement an Underground
20 Storage Tank Installer
21 Certification Program. This
22 is a program the regulated
23 community requested that The

Page 34

1 Department implement.
2 These proposed
3 regulations will require
4 individuals to complete
5 classroom training and
6 experience requirements to
7 become certified in order to
8 perform underground storage
9 tank system installations,
10 closures, and repairs. These
11 proposed regulations will
12 require that a certified
13 installer be present at
14 certain critical junctures of
15 the tank system installations,
16 closures, and repairs.
17 In addition, there
18 are certain other regulatory
19 updates and corrections to
20 Chapter 15 that are included
21 in this rule-making.
22 On November the 4th,
23 2011, The Department held a

1 public hearing to receive
2 comments concerning these
3 proposed revisions. No
4 comments were received
5 concerning this rule-making.
6 The Department recommends that
7 these revisions to Chapter 15
8 of Division 6 be adopted as
9 proposed.
10 And I'll be glad to
11 answer any questions you may
12 have.
13 CHAIRMAN LESTER: Any questions
14 from the Committee?
15 MR. BROWN: I move to adopt it.
16 DR. RICHARDSON: I have a
17 question.
18 CHAIRMAN LESTER: Oh, I'm sorry.
19 DR. RICHARDSON: Who is going to
20 do this training, and how much
21 is it going to cost the
22 individuals to get certified
23 to take this training?

10 Water Quality Programs
11 Underground and Aboveground,
12 Tank Trust Fund Regulation.

The Trust Fund Charge is proposed at \$0.01 per gallon. The Department held a public hearing on the proposed revisions on November 4, 2011.

9. CONSIDERATION OF ADOPTION OF PROPOSED NEW DIVISION 17, MEDICAL WASTE PROGRAM REGULATIONS WITHIN THE ADEM ADMIN. CODE AND AMENDMENTS TO ADEM ADMIN. CODE DIVISION 335-13, SOLID WASTE PROGRAM REGULATIONS

The Commission will consider the adoption of a proposed new Division 17 within the ADEM Admin. Code titled Division 335-17, Medical Waste Program, to replace the current definitions in Division 335-13, Solid Waste Program Regulations, Rule 335-13-1-.03 and Rules in 335-13-7 regarding the ADEM medical waste program. The proposed Division 335-17 will create a separate medical waste rule from the solid waste program. Rule 335-13-1-.03 is also being amended to add definitions resulting from passage of Alabama Law 2011-258 regarding management and disposal of coal combustion residues and ashes. The Department held a public hearing on the proposed new division and amendments on November 9, 2011.
